

## INFORMATION CLAUSE ON DATA PROCESSING ON PAYEYE'S YOUTUBE CHANNEL

Pursuant to Article 13(1) and (2) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (hereinafter: **GDPR**), we inform you how we will process your personal data provided when using the PayEye channel on YouTube (hereinafter: "**PayEye Channel**").

### And. Categories of data subjects

We hereby inform you that PayEye Sp. z o. o. with its registered office in Wrocław at Zwycięska 43, 53-033 Wrocław, processes personal data of persons who:

- a. subscribed to the PayEye Channel by clicking the "Subscribe" icon;
- b. posted their comment under any of the videos posted on the PayEye Channel.

### II Personal data administrator

The administrator of the personal data of the persons specified in point I is PayEye Sp. z o.o. with its registered office in Wrocław, Zwycięska 43, 53-033 Wrocław (hereinafter: "**PayEye**", "**We**"), as well as the administrator of the YouTube portal, i.e. Google LLC (hereinafter: "**Google**"), as jointly responsible for the processing of data of persons using the PayEye Channel. ### III Contact details of the Data Protection Officer

We have appointed a data protection officer. This is the person you can contact in all matters related to the processing of personal data and the exercise of rights related to data processing. You can contact the inspector in the following ways:

### IV Purposes and grounds for processing

We process personal data of persons specified in point I for the following purposes:

- a. administer and manage the PayEye YouTube Channel, including responding to comments posted and supervising the content published by users, on the terms and conditions set out by Google and informing about our activity through it, promoting various events that we organize, as well as our brand, products and services, building and maintaining a community associated with us and for the purpose of communication via available YouTube functionalities (videos, comments, posts) which is our legitimate interest (Article 6(1)(f) of the GDPR);
- b. responding to inquiries addressed to PayEye on YouTube in the comments – the legal basis for the processing is PayEye's legitimate interest consisting in the possibility of responding to persons contacting us (Article 6(1)(f) of the GDPR);
- c. establishing, investigating or defending against claims – the legal basis is the necessity of processing for the performance of the contract or the implementation of our legitimate interest (Article 6(1)(b) or Article 6(1)(f) of the GDPR)
- d. analytical analyses concerning the functioning, popularity, and manner of using the PayEye Channel, which is our legitimate interest (Article 6(1)(f) of the GDPR);
- e. for other purposes to which you have consented, provided that we ask you for your consent to the processing of personal data and you give such consent – the legal basis for the processing of personal data is consent (Article 6(1)(a) of the GDPR).

Giving consent in such cases is voluntary, although it may be necessary to achieve the purpose of data processing.

In addition, we would like to inform you that the administrator of the YouTube website, as a provider of tools related to the PayEye Channel, is an entity jointly responsible for the processing of data of persons using the PayEye Channel, which may process data for its own purposes based on other legal bases. In particular, Google, based on its own provisions and regulations, may collect and process information contained in cookies of visitors to the PayEye Channel. On the basis of the data collected in this way, Google may create anonymous summaries and statistics (e.g. on the number or profile of visitors to the PayEye Channel), which may be made available to PayEye as the operator of the PayEye Channel.

### V Categories of processed personal data:

PayEye will process the following data:

- a. basic identification data (name and surname, pseudonym) to the extent published by you on your own YouTube profile;
- b. data published by you on your YouTube profile, in particular in comments.

### VI Data recipients.

Your personal data may be transferred or made available:

- a. to the owner of YouTube on YouTube's unchanged data policy available at: [www.policies.google.com/privacy?hl=pl](http://www.policies.google.com/privacy?hl=pl);
- b. other YouTube users, if they are posted by you in posts or comments on the PayEye Channel;
- c. PayEye's employees or associates who support PayEye in its business, including those providing IT services, telecommunications, marketing, auditing or legal services, who process such data on behalf of PayEye on the basis of a personal data processing agreement or an authorisation to process personal data;
- d. public authorities and entities performing public tasks or acting on behalf of public authorities, to the extent and for the purposes resulting from the provisions of generally applicable law;
- e. other entities which, on the basis of relevant data processing agreements signed with PayEye, process personal data on behalf of PayEye.

## **VII Transfer of data to third countries or international organizations.**

PayEye does not transfer data outside the EU or the European Economic Area, subject to the supranational nature of data flows within YouTube with the use of contractual clauses used by Google approved by the European Commission and decisions of the European Commission stating an adequate level of data protection in relation to specific countries in accordance with the principles set out by Google at: [www.policies.google.com/privacy?hl=pl](http://www.policies.google.com/privacy?hl=pl).

## **VIII Data retention period**

The period of data processing is related to the purposes and grounds for their processing. Therefore:

- a. the data will be processed for the period in which you are an active user of the PayEye Channel or until you object;
- b. the data contained in the comment will be processed until they are deleted;
- c. data processed on the basis of consent will be processed until the consent is withdrawn;
- d. data processed on the basis of statutory requirements will be processed for the time in which the law requires the data to be stored;
- e. data processed on the basis of PayEye's legitimate interest will be processed until an effective objection is filed or this interest ceases, e.g. data processed for the purpose of pursuing or defending against claims will be processed for a period equal to the period of limitation of these claims;
- f. regardless of the storage of data by PayEye, the YouTube administrator may apply its own data storage periods.

## **IX Your rights:**

You are entitled to:

- a. The right to access your data and receive a copy of it;
- b. The right to rectify (correct) your data;
- c. The right to erasure;
- d. The right to restriction of processing;
- e. The right to object to data processing;
- f. Right to data portability;
- g. The right to lodge a complaint with a supervisory authority,

(22) 531 03 00 - when you believe that the processing of your personal data violates the provisions of the GDPR or other regulations on the processing of personal data;

- h. The right to withdraw consent to the processing of personal data.

You have the right to withdraw your consent to the processing of this personal data processed on the basis of consent at any time. Withdrawal of consent will not affect the lawfulness of processing based on consent before its withdrawal.

## **X. Data Source Information**

We obtain your data from Google and from your public profile, as well as posts on the PayEye Channel on the YouTube social network.

## **XI. Other information**

Providing data within the PayEye Channel is voluntary. PayEye will not make decisions with respect to you in an automated manner, including as a result of profiling, which have legal effects on you or have a similar significant impact on you.
